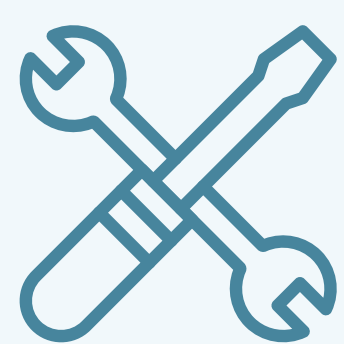

2 Construction Project Management

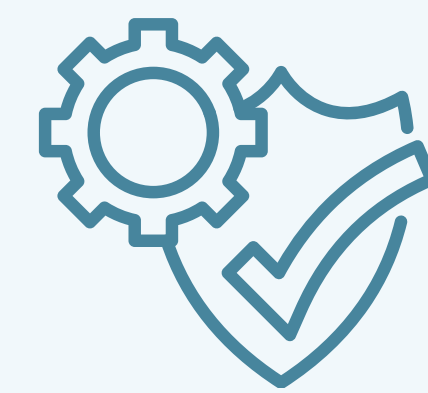

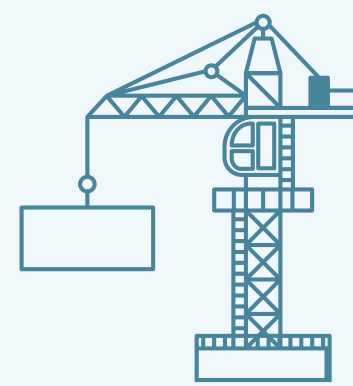


3 General Construction

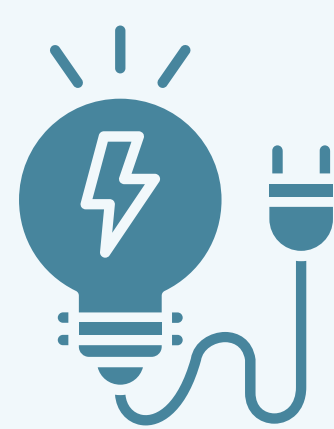


5 Energy Industry

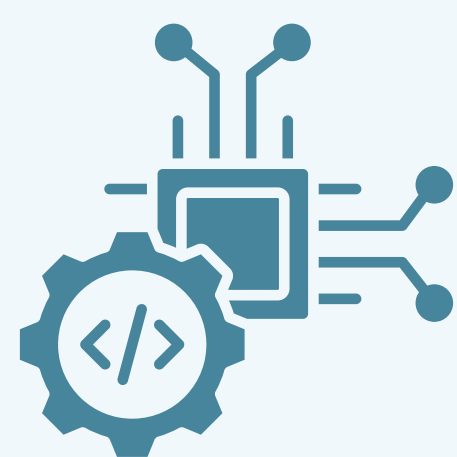

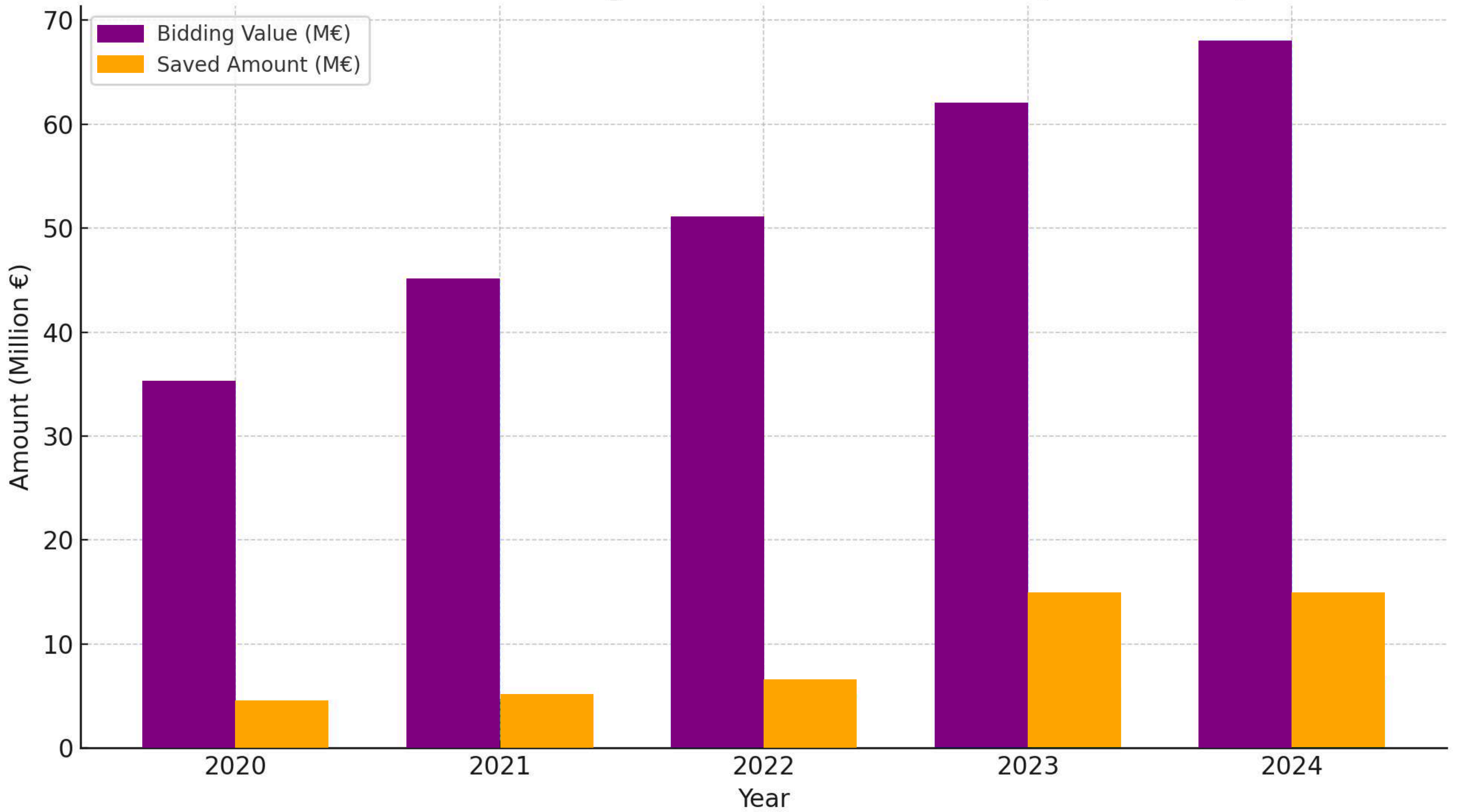




Saved Value Statistics
